Unfortunately, SSALBT is not online and will need to be administered by a qualified instructor. If you need this training, please indicate on your registration form.

### Participant Agreement



Sea Badge Course Participant Agreement is designed to inform the participant of the National Sea Scout Committee's participant expectations.

National standards for participants are as follows:

All attending participants agree to wear the White Sea Scout uniform from cover to shoes and socks.

All attending participants will participate in a uniform inspection, during Sea Badge, to further illustrate those standards.

All participants will provide their Ship's standard uniform and work uniform (if available) for their Sea Badge course.

All participants will create and provide a personal burgee to share with their Sea Badge Ship's Company.

All participants will provide a signed copy of this form and the previous *completed* form with their registration.

As a participant, I understand that I must have either taken SSALBT offered by a qualified instructor or make myself available for a course prior to Sea Badge CR-X. (If situation demands, SSALBT *may* be offered at the beginning of CR-X)

As a participant, I understand that I need to have at least one year as a registered adult with a Sea Scout Ship.

As a participant, I understand that I *must* obtain the signature of the Scout Executive from my home Council.

As a participant, I understand that I will be placed in a Crew as part of the Ship's Company, EX: Alpha, Bravo, Charlie, or Delta, etc. for the duration of the Sea Badge course.

As a participant, I understand that there are limited spaces available for this Sea Badge course and that first choice will be made available to those participants who have submitted their completed application and fully paid registration fee.

As a participant I understand that the staff is here as volunteers and as such deserve my respect and attention.
